Criminal Code

The Acting Speaker (Mr. Blaker): The Parliamentary Secretary is fortunate that both my ears are working at the moment. In any event, the matter is settled. The Opposition day to which the Parliamentary Secretary referred is Friday, not tomorrow.

Mr. Baker (Nepean-Carleton): Mr. Speaker, I rise on a point of order. My friend cleared up the confusion and then added to it. We now understand that Friday is an allotted day. Certain announcements have been made; we have been informed of the business for tomorrow, Thursday. Have there been any changes in the Government's mind with respect to the business for tomorrow?

Mr. Smith: No, other than the fact that the House order which was approved a few moments ago calls for a vote at three o'clock. Apart from the vote, the business will be as stated earlier by the Government House Leader.

The Acting Speaker (Mr. Blaker): Shall all items listed under Private Members' Public Bills preceding No. 424 be allowed to stand by unanimous consent?

Some Hon. Members: Agreed.

AMENDMENT RESPECTING GREYHOUND RACES

Motion agreed to, Bill read the second time and referred to the Standing Committee on Justice and Legal Affairs.
