ANNUAL GENERAL MEETING, OCTOBER 9TH, 1861.

The Annual General Meeting of the Diocesan Church Society was held in the National School, Halifax.

The Right Rev. the President took the chair at two o'clock, p. m. After prayers and reading the Minutes of the last general meeting,-

The following officers for the ensuing year were appointed: The Rev. Edwin Gilpin, A. M., Secretary; H. Pryor, Esq., D.C.L., M.P.P., Assistant Secretary; W. C. Silver, Esq., Treasurer. Also, as new members of the Executive Committee: T. A. Brown, Esq., E. D. Meynell, Esq., W. Hare, Esq., J. T. Lordly, Esq., G. E. Harvey, Esq., and Capt. Lyttleton.

The hearty thanks of the Society were tendered to the office-bearers, for their services during the past year.

A letter was read from the Secretary of the "Church Endowment Fund," stating that about £18,000 had been subscribed, and expressing a wish to resign his office, in consequence of his proposed departure from the Province.

Some discussion having taken taken place relative to the Endowment Fund, it was determined that an effort be made to raise the subscriptions to £20,000.

"It was resolved, that the action of the Executive Committee in publishing the Annual Report early in the year, be approved, and that they be directed to follow the same course in future."

The meeting adjourned to Wednesday, October 30th, then to take up the subject of the Endowment Fund.
