

came a corporal on November 1, 1961. He purchased his discharge on October 30, 1964, to join the Quebec Provincial Police, but eight months later returned to the Force as a constable. He was promoted to corporal on May 1, 1966, and transferred to Visa Control duties in Marseille, France, that same month. In July of 1969, he was posted to Paris, France, and in October of that year was made sergeant. In June 1970, he returned to "C" Division S.I.B. On October 1, 1971, he was promoted to staff sergeant. In August 1975, he returned to Paris on Foreign Service duties, staying there until August of 1979, when he was returned home to Montreal. He retired on November 30, 1979.

GRANT Reg. No. 13706, ex-S/Sgt. Ian Duncan Grant, 63, died August 18, 1982, at New Westminster, British Columbia. Born February 1, 1919, at Harmattan, Alberta, he joined the RCMP on September 4, 1940, at Calgary, Alta., and took his recruit training at Depot Division. He spent his entire service in "F" Division serving at Lloydminster, Spiritwood, North Battleford, Meadow Lake, Loon Lake, Radisson, and Regina. On April 1, 1963, he was appointed NCO i/c Saskatoon West Section. Before being discharged to pension on June 12, 1965, he had been promoted to constable on January 25, 1946; corporal on December 1, 1954; sergeant on May 1, 1961; and staff sergeant on May 1, 1964.

JONES Supt. Malcolm Ward Jones (Rtd.), 75, died March 13, 1982, at Victoria, B.C. Born May 9, 1906, at Apohaqui, New Brunswick, he joined the Force at Edmonton, N.B., on April 1, 1932 (Reg. No. 11670), after a short term of employment with the Preventive Service. Upon completion of recruit training at Depot, he was transferred to "F" Division where he served at Saskatoon and Regina Town Station before being posted to "K" Division where he worked at Edmonton, Vegreville, Camrose, and Derwent Detachments. In March 1939, he was posted to "A" Division, Ottawa, and promoted to lance corporal a year later, December 1, 1940, while employed in the Intelligence Section. In April of 1941, he was promoted to corporal, two years later to sergeant, and on November 1, 1947, staff sergeant. On August 1, 1951, he was promoted to sub-inspector and appointed D.P.O. of "F" and Depot Divisions. Two years later, he was promoted to inspector and posted to Ottawa HQ as Assistant Supply Officer. In August 1957, he was transferred to "E" Division, S.I.B., and promoted to superintendent on April 1, 1960. He continued in S&I duties at Vancouver until his retirement on May 19, 1966.

MacINTOSH Reg. No. 12195, ex-Cpl. James MacIntosh, 84, died June 21, 1982, at North Sydney, Nova Scotia. Born June 30, 1897, at Sydney Mines, Cape Breton, N.S., he served with the Customs and Excise Preventive Service for one year prior to joining the Force on April 1, 1934, at Halifax. During the ensuing years as a member of

the Marine Section he crewed on cruiser "No. 4," "Alachasse," "Islander," "Arresteur" and patrol boat "Brule," working out of "H" and "L" Divisions. In October of 1939, he enrolled in the Royal Canadian Naval Reserve and did service on the high seas, Atlantic zone, during WW II. He had previously served with the Canadian Expeditionary Force, 85th Battalion, in England and France during WW I. Upon returning to the RCMP at the termination of hostilities, he was promoted to corporal in the Marine Section on June 28, 1945. He was on command to the "Brule" when he took his retirement on July 24, 1953.

MANSBRIDGE Reg. No. 14635, ex-S/Sgt. John Cecil Mansbridge, 58, died May 26, 1982, at Winnipeg, Manitoba. He was born March 7, 1924, at Alix, Alberta, and served with the RCAF from October 2, 1941, until June 25, 1945, attaining the rank of flying officer, before joining the RCMP on February 19, 1946, at Edmonton, Alberta. Following recruit training at Depot Division, he was posted briefly to "N" Division, Rockcliffe, then to "D" Division, where he served subsequently at Carman, Beausejour, Winnipeg, Grand Beach, Lac du Bonnet and Sprague. He was promoted corporal on November 1, 1955, sergeant on May 1, 1964, and staff sergeant on May 1, 1966. He retired to pension on October 7, 1968.

MORLEY Reg. No. 7700, ex-S/Sgt. William George Morley, born December 29, 1899, died at Winnipeg on January 5, 1982.

PEARCE Reg. No. 8324, ex-Cst. Albert Victor Pearce, 87, died at Duncan, B.C., on July 9, 1982.

SMITH Reg. No. 11808, ex-Sgt. Harry St. Clair Rossland Smith, 76, died June 5, 1982, at Virden, Manitoba. Born April 10, 1906, at Virden, he joined the Force at Winnipeg on November 14, 1932. He was posted to "F" Division on May 1, 1934, and stationed at the Regina Motor Pool because of his extensive experience in the past as a mechanic. In August of 1938, he was returned to the Depot Post Garage. He was promoted to corporal on December 1, 1944, and sergeant on May 1, 1952, as NCO i/c Post Garage. On November 30, 1953, he retired from the Force.

STEVENS Reg. No. 16435, ex-Cst. Malcolm Stevens, 68, died July 11, 1982, at Surrey, British Columbia. Born October 29, 1913, at Edmonton, Alberta, he joined the RCMP on January 21, 1943, at Vancouver, B.C. He served in the following locations in "E" Division: Williams Lake Detachment, Vernon Detachment and Creston Detachment. He left the Force on February 7, 1958.

VALLANCE Reg. No. 8846, ex-Cpl. M. L. Vallance, 82, died October 8, 1981.

VICKERS Reg. No. R/829, ex-R/Cst. Frank Vickers died September 26, 1982, at Toronto, Ontario.
