The expenses of the committee which shall be limited to \$10,000 shall be paid, one-half from the contingent fund of the Senate and one-half from the contingent fund of the House of Representatives: Provided, That Senate Resolution Numbered 411, agreed to January 25, 1923, be, and the same hereby is, discontinued in force and effect.

SIR,—I beg to advise, for the information of the Government, that a meeting of the National Advisory Committee, St. Lawrence Waterway, was held at Ottawa, on January 5th, for the consideration of the draft instructions to the enlarged joint engineering board which will report upon the engineering problems involved in the project. The meeting of the Committee was fully attended and the members had the advantage also of the presence of Mr. D. W. McLachlan, Chairman of the Canadian section of the joint board of engineers, and the two technical officers-Brig.-General Mitchell and Mr. O. Lefebvre-who represented Canada at the conference at which the Terms of Reference were drafted, and the deliberations of the Committee were greatly assisted by the explanations and information these officers were able to bring to bear upon the discussions. After dealing fully with both the original report of the technical officers of June 20th, and the supplementary report of December 4th, it was moved by Sir Clifford Sifton, seconded by Hon. Adelard Turgeon, and unanimously resolved, that the Terms of Reference as agreed upon by the technical officers representing both countries be recommended for adoption by the Government.
