In a most interesting article in the Revue Scientifique, a well known French physician, Dr. Chibret, breaks a lance for cycling from a medical point of view. He says that on a cycle the attitude of the body is that of a quadruped, and no longer of a biped, and is marvelously adapted to realize a maximum of motion with a minimum of fatigue. Favor the front tire with less inflation than the rear one, which has all the weight of the rider to support. No tires should be inflated beyond a point where a certain amount of "give" results from thumb pressure. If you must commit an error in tire inflation let it be in the direction of too little, not too much, inflation. The heavier the rider the harder the tires must be inflated. On wet and slippery roads the harder the tire is pumped the less danger will there be. -The Wheel.

The Prisoner Welter Makes a Remarkable Statement.

Tries to Fasten the Crime On Another Man

And to Exonerate Hendershott and Himself - Evidently a Fake Story to Gain Time - Breaking the News to the Cendemned Men.

St. Thomas, June 17.—Another and ed to the history of the Welter-Hendershott case, the prisoner Welter making a statement reasserting his innocence, but acknowledging, what the defense has all along denied, that the tragedy was a murder, and not an ac-

cident. Welter endeavors, in his statement, to fasten the crime on a well-known and highly respected resident of the township of Southwold. On its face, this part of his story bears every evidence of improbability, is supported by no circumstances adduced at the three investigations, and is evidently an eleventh hour attempt to save himself at all hazards from the terrible fate

overhanging him. EXCITEMENT RAN HIGH in St. Thomas last night, between 10 p.m. and 2 o'clock this morning, the statement that Welter had made a confession flying from mouth to mouth, and being the cause of many a citizen being aroused from his slumbers. About 10 o'clock last night Mr. D. J. Donohue was called to the jail, and

there a statement was made to him by Welter, who was spending the night in the same ward with Hendershott. To other persons the statement was also made, among them being, it is understood, Judge Hughes and Rev. D. Spencer. It is said that the latter gentleman was the first in whom Welter confided, although he had been communicating along the same lines to Turnkey

THE STATEMENT.

Both prisoners bore marked evidence of the terrible strain upon them, and Welter, in particular, was suffering severely as he told his story. This story was to the effect that young Hendershott had been murdered by a neighbor with whom the family had had some difference of opinion. That the speaker, Welter, had afterwards come upon the scene and discovered the crime, and had concealed it because the perpetrator had threatened to kill him also if he told what he had seen and knew.

Asked if he had told this extraordinary story to anyone, he said, "No." "Did you not tell it to Hendershott?"

"Why did you not tell it at the inves-"Because the man who killed Hendershott had threatened to also kill "Why did you not tell it to your coun-

"Because he told me he would get me

off in any case."
DO AS HE LIKED WITH IT. Mr. Donohue cross-questioned Welter at considerable length regarding the details of this story, but could glean nothing which served to corroborate it or make it appear in any degree reasonable. Asked what was to be done with the statement, Welter said Mr. Dono-hue was to do with it as he saw fit communicate it to the Minister of Justice, to the press, or otherwise dispose of it as he thought best. HENDERSHOTT HAD NOTHING TO

SAY. The prisoner Hendershott was asked what he thought of this story, and his answer was that he didn't know. "Did Welter ever tell it to you?"

"When did you first hear if it?" "I heard Welter telling Rev. Mr. Spencer." "Do you think it is true?"

"I don't know." THE MINISTER APPRISED. About 2 o'clock this morning Mr. Donohue left the jail, and was immediately besieged by the reporters. He was very reticent, but stated that he felt it to be his duty to convey the statement to the Minister of Justice. He wired him early this morning. No doubt the Crown Attorney will at the same time acquaint the Minister with his opinion of the value of the state-

men INFORMED OF THEIR FATE.

worked so faithfully in their behalf. "He first saw Hendershott, but after

shaking hands with him and having a private word, passed on to Welter's cell. Welter did not seem unprepared for the interview, and as he anxiously peered into the face of his counsel as the two stood facing each other with clasped hands, he undoubtedly read therein that which was so hard for the lawyer to tell. Said Mr. Macdonald: "I have done all that any man could do. I feel it the most unpleasant duty of my life to be obliged to tell you that there is no longer any reason for hope You have now to do with your spiritual

adviser and your God." For a moment the prisoner and his counsel stood with hands tightly clasped. A cold perspiration moistened his hands, while a short gasp, which escaped him in spite of his efforts to maintain a calm outward composure, for a moment convulsed his frame. He gave no further evidence of the terrible struggle which must at that moment have been going on within him. countenance remained unmoved, and at this, the supreme moment of his life, he strikingly bore out the remark of Chief Justice Meredith, that he had the most wonderful nerve of any man he

had ever seen. Welter's simple request was that the sheriff be seen and allow his sisters Mrs. Boughner and Mrs. La Monte, the latter of whom is a resident of Buffalo, to see him. Mr. Macdonald acceded to the request, and subsequently the relatives saw their brother for the last time Before he parted with the condemned man, Welter said that he had heard that Mary Hendershott and Charley Welter had been arrested in connection with the murder, and that Provincial

Detective Murray was in the city. Mr. Macdonald said that such was not the case, and that if such a rumor was in circulation it could only have one meaning-that it had been given out with the object of extorting a confession from either him or Hendershott. "If that is the case," said Welter, "they are after the wrong nigger." This ended the interview, and as Mr. Macdonald prepared to leave the ac-

cused, he asked him to be brave, now that he had to face death, to die like a man. Welter said: "You can trust me for

Mr. Macdonald walked across the corridor to Hendershott's cell, and found him deeply absorbed in his Bible. Hen-dershott was not entirely unprepared for the interview, having in part heard the conversation which had passed between Welter and their counsel. He was much more depressed, however, than Welter, and gave way to his emotions.

"I suppose you have heard what we have been talking about?" said Mr. Macdonald, as he took the prisoner's extended hand.

"Yes," answered Hendershott. "What an awful position to be placed in."
"Yes," said the lawyer. "Death is always awful in any form, but after all it makes little material difference whether we die today or twenty years hence, and" (jocularly) "there are many people today who would gladly trade positions with you."

Hendershott tried to return his friend's sally, while a ghastly smile for a moment lit up his features. He said: 'I would like you to produce some of them, and I would trade positions with them mighty quick." Mr. Macdonald consoled with the pris-

oner, and encouraged him to meet his fate as befitted a man. He promised to see him often, and counseled him to look to his spiritual welfare, in which he would find great solace during the trying hours that separated him from his last moments.

Hendershott was engaged to a most estimable young woman in St. Thomas, and asked if she had seen him during his confinement, he answered no, but expressed a desire to see her before he died. This request was not permitted by the jail authorities. Before Mr. Macdonald left Hender-

shott, he had regained his composure, and premised to bear up bravely THE RELATIVES PROSTRATED. Probably the most trying duty which

Mr. Macdonald has been called upon to perform was in imparting to the relatives the news he had received from Ottawa. After leaving the jail he drove at once to the home of Prisoner Welter's sister, Mrs. Boughner, where were assembled, besides Mrs. Boughner, Miss Hendershott, Mrs. Welter, mother of the prisoner, and Mrs. La Monte, of Buffalo. The news came to Mrs. Boughner with crushing force. When informed of the Ottawa report, she at once fell into a swoon, from which she was not revived until a physician had been summoned by Mr. Macdonald. The other relatives were also prostrated. THEIR SPIRITUAL ADVISER.

Rev. Mr. Spencer spent half an hour with the prisoners on Saturday, engaged in earnest prayer. The men took the greatest interest in his ministrations. Mr. Spencer also saw them on Saturday night, during which time the men had been made aware of the fact that the law must take its course. Mr. Spencer said to the reporter that, while the men showed signs of emotion, they had not given way completely, and conducted themselves in a most courageous manner, considering the strain on their THEIR LAWYER'S OPINION.

Lawyer Macdonald, when asked if the prisoners had confessed, said: "Both the prisoners up to the present moment have assured me of their innocence. I do not know, however, whether they are guilty or not, and I do not believe that another man lives who does. My professional duties debar me from making public any statement, but at the same time I do not desire the impression to go to the public that I consider them guilty." THE BRUTAL HANGMAN.

One of the shocking things in this whole case is the behavior of Hangman Radcliffe. He is the center of attraction about the hotel corridors, and poses as a man of mystery, at the same time putting himself in the way of the newspaper interviewer, to whom he talks in the most cold-blooded way. At Knox Church last evening, before a large congregation, Rev. J. A. Macdonald said

the awful event which will mark this week. "It is to be regretted," he said, "that there are so many who are unwilling to give these condemned men the criminal's privilege of respectful silence. And it is to be regretted that our local press, of which at other times we have just reason to be proud, has to a degree persisted in pandering to this inordinate hunger for the horrible, publishing brutally exact interviews with a man whose name ought never to have been mentioned, and whose coarse and heartless sayings ought never to have been reported."

NO REPRIEVE. (Special to the "Advertiser.")

Ottawa, June 17.—As announced in the "Advertiser" some time ago, Hendershott and Welter must hang tomorrow at St. Thomas. The formal reply of the Minister of Justice, given on Saturday to this effect, will not be changed by any reported confessions of one or other of the prisoners. Such a confession, coming at the eleventh hour, is not allowed to interfere with the decision deliberately arrived at.

JAPAN DISSATISFIED.

The People Are Not Pleased by the Government's Concessions to the Powers.

Victoria, B. C., June 16.—Advices from the Orient by the steamer Empress of Japan indicate that popular discontent at the submission & Russian intimidation has far from subsided, and that further political complications may yet result from it. Rumor has it that Russia is preparing to take possession of Port Lazareff in Corea and great indignation is expressed that the Japanese Government has taken no active steps to prevent this fresh indignity. In the meantime Russia is pushing forward fortifications at Vla-

divostock with all possible vigor. Though the newspapers joining in the utterances of popular feeling are promptly suppressed, the Japanese Government is taking pains to keep posted as to the real attitude of the populace in various portions of the empire, and the Provisional Government has been ordered to report with great detail on this subject. The result has not been encouraging to the Administration, for these confidential reports, of necessity, give but the one story, that of condemnation. None but constitu-tional opposition is anticipated, however, and the Japanese forces are being rapidly disbanded, so that the soldiery may return to their peaceful avoca-tions. The Government of Corea seems to be utterly demoralized, and Russian gold is reported to be exercising a powerful influence there.


