There is undoubtedly a good deal of dissatisfaction in the country over the distribution of the Canadian patriotic fund, 402.

Bennett, W. H. (Simcoe East)-397.

Rates paid to officers and privates, and other matters referred to connected with the fund, 397-8.

Borden, Rt. Hon. Sir Robert (Prime Minister) 395.

Refers to allotment of soldiers' pay for dependents, 395.

Doherty, Hon. C. J. (Minister of Justice)—393.

The provisions of this amendment empower the corporation to assist incapacitated soldiers who may return from the war.

Macdonald, E. M. (Pictou)-398.

Asks status of men married after enlistment in regard to fund, 398.

I say that the money that is going to the dependents of our soldiers is not going as a charity. It is going as philanthropy; it may be going as a benevolence; but it is going as the grateful gift of the people of the community, 401.

Oliver, Hon. Frank (Edmonton) -395.

Thinks responsibility for dependents of soldiers rests primarily upon the State, 395-6. If fund comes to be larger part of support of dependents, it is charity, and not payment of a debt owed by the country, 401.

Turriff, J. G. (Assiniboia)-400.

Has the separation allowance been paid to the families of men who did not go with the first contingent, 400.

Wilcox, Oliver (Essex North)-399.

What arrangements is made as to assistance to wives and families of soldiers when they live in the United States, 399.

#### CANADIAN PACIFIC RAILWAY.

As to weakening the Canadian Pacific Railway company, I cannot see that this Bill weakens it, and I think the company is pretty thoroughly able to safeguard its interests. As a matter of fact, there is not a great deal of change in the situation, as far as I understand it, 750.

Carroll, W. F. (Cape Breton South)-

Argues that legislation does not put services outside jurisdiction of Railway Commissioners, 743-4.

Cochrane, Hon. Frank (Minister of Railways and Canals)—746.

I do not see any harm in this Bill, 746.

Graham, Hon. G. P. (Renfrew South)-751.

It is much more difficult to regulate ocean freight rates than it is to regulate railway freight rates. There are several difficulties in the way: I sympathize with the Government in that they are finding it not easy to do something in the accomplishment of which their predecessors did not exactly succeed, 752-3.

Macdonald, E. M. (Pictou)— Favours Bill, 748-9.
