Hon. G. J. McIlraith (Minister of Public Works): Yes, between the years 1910-1915 by Mr. L. R. Voligny. A review of the report was made in 1961 at which time it was concluded that there would not be a sufficient volume of traffic to provide significant transportation savings to set against the heavy capital and operational costs which would be involved in the construction of the waterway.
