GOVERNMENT EXPENDITURES RESTRAINT ACT

AMENDMENT TO REMOVE CERTAIN RESTRICTIONS RESPECTING TRAINING ALLOWANCE RATES

The House resumed, from Wednesday, November 17, consideration of the motion of Mr. Andras that Bill C-19, to amend or repeal certain statutes to enable restraint of government expenditures, be read the second time and referred to the Standing Committee on Miscellaneous Estimates.

Mr. Bob Brisco (Kootenay West): Mr. Speaker, last week when it was necessary to terminate my contribution to the debate on this bill I had discussed certain concerns with regard to the outflow of Canadian dollars into the United States. Having said that, I would like to move on to continuing complaints, perhaps more of a keening and wailing from the Liberal benches such as we are hearing right now—

Some hon. Members: Oh, oh!

Mr. Brisco: —that we oppose, as we should; that we criticize, as we should. If hon. members opposite have a sensible contribution to make, I suggest they wait until they hear what I have to say. I do not mind criticism as long as it is constructive, but when one has the floor and has to listen to aimless drivel from the other side it is not particularly enjoyable.

One concern advanced by the hon. member for Comox-Alberni (Mr. Anderson), that the official opposition does not offer credible alternatives, is a pack of rubbish. I suggest to the hon. member for Comox-Alberni, as I suggest to all members on the Liberal backbenches, that he read the speeches made in this House by members of the opposition on Bill C-68. I suggest that he look at the constructive criticism and the amendments that were in fact accepted by that government and introduced by the opposition.

I also suggest that members opposite look at the constructive criticism which was so effective with regard to Bill C-83. That died on the floor of this House because the criticism forced the minister to hold back rather than continue during the month of July. If the Minister of Justice was anxious to see that bill go through in the form in which it was presented, it would have gone through at that time. If the government really felt it was right, we would not have adjourned. It is not a question of the opposition wanting to spend more—as the hon. member for Comox-Alberni maintained in his speech on Bill
