KURT WALDHEIM—INQUIRY CONCERNING ADMISSIBILITY TO CANADA

Yesterday the United States announced that Kurt Waldheim, President of Austria, has been placed on their "watch list" and that he is no longer welcome in that country because of the war crime allegations that have been levelled against him, and he will not be allowed into that country until the issue is satisfactorily resolved.

My question for the Minister is: Will Canada be taking a similar position should Mr. Waldheim ask to visit our country?

Right Hon. Joe Clark (Secretary of State for External Affairs): Mr. Speaker, there is no plan to have Mr. Waldheim visit this country, nor is there any intention on his part to visit Canada

A question similar to the one raised by the Hon. Member was put to the Prime Minister earlier today, and the Prime Minister made it very clear, in response, that Mr. Waldheim would not be welcome in Canada.

REQUEST FOR CLARIFICATION OF PROPOSAL MINISTER INTENDS TO INTRODUCE

Mr. Raymond Garneau (Laval-des-Rapides): Mr. Speaker, my question is for the Minister of Finance and has to do with the tax reform as well. The Minister has just stated in the House that he intends to table a proposal before the end of

SOUTH AFRICA—CANADIAN GOVERNMENT'S POLICY

Mr. Howard McCurdy (Windsor—Walkerville): Mr. Speaker, my question is addressed to the Secretary of State for External Affairs.

On April 15 last, the Minister said that the Government would take no additional action against South Africa until after the elections. In the meantime, the Government of South Africa has used those very elections as an excuse for increased oppression and violence, and most recently for an attack against Zambia.
