- (6) Weekend replay of the previous week's proceedings of the special joint committee.

Madam Deputy Speaker: Does the hon. parliamentary secretary have the unanimous consent of the House to move the motion?

Some hon. members: Agreed.

Mr. Peter Milliken (Kingston and the Islands): Madam Speaker, I rise on a point of order. I think the parliamentary secretary in his point about replay of the proceedings meant to replay those parts that had not been played live. Is that correct? I wonder if he could confirm that.

My understanding is that the House will be played live. Question Period and Statements under Standing Order 31 will be replayed. Then any live proceedings of the committee then taking place will be played. Then any committee proceedings taped during the House proceedings, for example, or at other times that have not been played would be played and then the replay of the House would follow as number five.

I wonder if he could confirm that that is the understanding. I do not think it is the intention to replay the special committee's proceedings immediately and not replay the House. Is that the understanding?

CANADA LABOUR CODE
