9. And be it enacted, That any person whose name shall be inadvertantly or otherwise omitted to be entered on the Assessment Roli, shall nevertheless be liable to perform Statute Labour in the same proportion as it no such omission had taken place : Provided always, that immigrant labourers, who have not resided full six months in this Province, shall not be liable to perform Statute Labour.

## BY-LAW NO XVII.

A BY-LAW to provide for the protection and preservation of any Timber, Stone, Sand, or Gravel, growing or being upon any of the public Highwaye, Streets, Squares or places of the Town of Peterborough.

## Passed 25th March, 1850.

E it enacted by the Town Council of the Town of Peterborough, and it is hereby enacted by authority of the same, That any person, who shall carry away, dig, or otherwise disturb. or interfere with any Stone, Sand, or Gravel being upon any of the public highways, Streets, Squares, or places of the said Town; or who shall cut down, injure, remove or otherwise interfere with any Timber, growing or being upon any of the said public places, without leave in writing first being granted to such person by the said Council. shall, on conviction, be liable to a fine of not less than five shillings for each and every such offence, to be recovered in the same manner as other penalties inflicted by any By-Law of this Council.
