**CANADIAN SOVEREIGNTY****POSITION RESPECTING ARCTIC ARCHIPELAGO, CONTINENTAL SHELF AND INTER-ISLAND WATERS**

**Mr. John Burton (Regina East):** Mr. Speaker, I wish to direct a question to the Acting Prime Minister. In view of recent statements by the Minister without Portfolio from Saskatoon-Humboldt that there is no question of Canada's sovereignty over the Arctic Islands, the continental shelf and the spaces between the islands, could the Acting Prime Minister indicate whether this is in fact the case and whether all the problems have been resolved with respect to Canada's sovereignty? What is the situation in this respect?

**Hon. Mitchell Sharp (Acting Prime Minister):** Mr. Speaker, I am sure hon. members will agree that the complexities of international law are such that it would not be possible for me to answer this question in a short time even if I had the competence to answer it.

**Mr. Burton:** A supplementary question, Mr. Speaker. Could the Acting Prime Minister indicate whether the problems connected with Canada's sovereignty, particularly with regard to the waters between the islands, have been resolved? That was the purport of the statement of the Minister without Portfolio. Would the Acting Prime Minister deal with that aspect of the situation?

**Mr. Sharp:** Mr. Speaker, the position is that Canada has a view about Canada's sovereignty. Unfortunately it is not universally accepted.
