Teacher's salary not to be lessened thereby.

To sue defaulters residing out of the section.

To notify and fix the place of the annual school meeting.
To call special meetings,

Mode of conducting special meetings. Copy of the proceedings to be sent to the local superintendent of schools. Continuance in office of persons elected to fill vacancies, To admit persons from 5 to 21 years of age to attend the school on certain conditions. Exception in certain cases. Toysit the School, &c.

To prohibit improper, and provide proper hooks for the School.

To be personably respons

naily responsible in the case of refusing or neglecting to exercise corporate powers for the fulfilment of contracts. To appoint a librarian and provide for the establishment and support of a school library. To ascertain

the number of resident children of school age. and the amount of the same shall be a charge upon the other rateable inhabitants of the school section, and shall not be deducted from the 2 salary of a Teacher.

Eleventhly. To sue for and recover by their name of office the amounts of school rates or subscriptions due from persons residing without the limits of their school section, and making default of payment.

Twelfthly. To appoint the place of each annual school meeting, 6 and to cause notices to be posted in at least three public places of such section, at least six days before the time of holding such meeting; to 8 call and give like notice of any special meeting of the resident house-holders of such section, for the filling up of any vacancy in the 10 Trustee corporation, occasioned by death, removal, or any other cause whatever, or for any other school purpose, as they may 12 think proper; to specify the object or objects of such meeting; which meeting shall be organized and its proceedings recorded in the same 14 manner as those of an annual school meeting; and a copy of them in like manner, shall be transmitted to the local Superintendent: 16 Provided always, that in case of a vacancy in the office of any of the Trustees, during the period for which they shall have been 18 respectively elected, the person or persons chosen to fill such vacancy, shall hold office only for the unexpired term.

Thirteenthly. To permit all residents in such section between the ages of five and twenty-one years of age, to attend the school, so 22 long as their conduct shall be agreeable to the rules of such school, and so long as the fees or rates required to be paid on their behalf, 24 are duly discharged: Provided always, that this requirement shall not extend to the children of persons in whose behalf a separate 26 school shall have been established according to the nineteenth section of this Act.

Fourteenthly. To visit the school from time to time, and see that it is conducted according to the regulations authorised by law.

Fifteenthly. To see that no unauthorised books are used in the school, but that the pupils are duly supplied with an uniform series 32 of text-books sanctioned and recommended according to law.

Sixteenthly. To be personally responsible for the fulfilment of any 34 contract or agreement made by them, unless they can prove that they have exerted all the corporate powers vested in them by this Act for 36 the fulfilment of such contract or agreement.

Seventeenthly. To appoint a Librarian, and to take such steps 38 as they may judge expedient, and as may be authorised according to law, for the establishment, safe-keeping and proper management of a 40 school library, whenever provisions shall have been made and carried into effect for the establishment of school libraries.

Eighteenthly. To ascertain the number of children between the ages of five and sixteen years residing in their section during the 44 month of December in each year; and to cause to be prepared and read at the annual meeting of their section, their annual school report 46 for the year then terminating, which report shall include among other things prescribed by law, a full and detailed account of the receipts 48
