Mr. Hazard's proposal states that he will undertake to Print them in the usual manner, at the prices formerly charged by him, which appeared on examination to amount to about Fifteen Shillings and Four pence halfpenny per page (the number of Ruled Pages in the Journal of last Session being only three;) your Committee therefore, are of opinion that an Agreement be forthwith entered into with Mr. White, and that he be required to give approved security for the due fulfilment of his Contract.

Resolved, that the House doth concur with the Special Committee in the said Report.

Ordered, that Mr. Dalrymple have leave to bring in a Bill to extend the Jurisdiction of Commissioners in matters of Small Debt.

He accordingly presented the said Bill, and the same was received and read the first time; and ordered to be read a second time on Tuesday next.

Then the House adjourned until Monday next at Twelve o'clock.
