The same applies to many in respect to spiritual things. We want to be good but we don't want to make any special effort in that direction. We want to be God created, machine Christians. God never created a machine Christian. He created man, an independent being, a little lower than the angels. He placed everything within reach for his good, spiritually and physically. To obtain the material things man must reach out with his physical arms and hands; to obtain the spiritual things he must likewise reach out with the arms of faith. The one is there just as certain as the other. We don't have to ask God to provide them. He has already done so. It is merely a matter of accepting it.

If the people of the world had been as eager to obtain the spiritual things as they were to obtain the material things, there would have been no war. When men become wholly absorbed in the securing of material things, they practice the tactics of animals, hogs in the pen, the big ones crowd the little ones out. There is no brotherly love in a hog pen, neither in people wholly absorbed in obtaining material things. It is when we reach out for spiritual things that brotherly love is in evidence.

Say, don't blame God for your shortcomings. Unless you are an imbecile, an idiot, you are alone responsible for them. It is blasphemous to say that God inspired the Kaiser to begin the war, in which millions have been slain and countless other millions made to mourn, to suffer untold agonies. It was the work of the devil.—Exchange.

Domination Temperance Alliance Convention

Will be Held in The Y.M.C.A. Hall, Fredericton, on Monday December 6th

The annual convention of the New Brunswick Branch of the Dominion Temperance Alliance will be held at Y. M. C. A. Hall, Fredericton, on Monday, Dec. 6th, 1915, at 8 o'clock, p. m. The object of the convention is to bring together in deliberate convention the temperance workers of this Province, in order to consider the temperance situation at the present time; to formulate a definite policy leading to the entire prohibition of the liquor traffic; to present this formulated policy to the Executive Council of the Province, which will be in session at the time of the Convention, and to transact the business of the Alliance and to perfect its organization as an effectual means of attaining the entire prohibition of the liquor traffic.

Churches of all denominations, Temperance Societies, W. C. T. U., Y. M. C. A., Labor Unions, or any other organizations in sympathy with the object of this convention, are entitled to send delegates. Delegates can secure standard certificates with their tickets and it is expected that ordinary railroad concessions can be secured.

The present opportunity is without parallel in the history of the temperance cause in our Province. The time is ripe. Calls have come to our Executive from religious leaders and moral workers throughout the Province, urging that this convention be called, and we earnestly request the hearty co-operation of Pastors, Temperance workers and moral leaders in this crisis that victory may be secured.
