INCOME TAX

AIR CANADA STRIKE—EXTENSION OF FILING DEADLINE

Hon. Jean-Pierre Côté (Minister of National Revenue): Mr. Speaker, notwithstanding the facts the hon. member has referred to, there is nothing to prevent our people from mailing their income tax returns before April 30.

Mr. Hales: A supplementary question, Mr. Speaker. Will the minister talk to his colleague, the Postmaster General, and ask him to make provisions for stamping in an appropriate manner all mail posted before midnight on April 30.
