STUDIES RESPECTING DEVELOPMENT OF NATIONAL PARK EAST OF JAMES BAY

Question No. 585-Mr. Laprise:

Have there been any studies made with respect to the development of a national park east of James Bay or elsewhere in the constituency of Abitibi and, if so (a) what did these studies consist of (b) who made them (c) were they made following a request from and in cooperation with the Province of Quebec?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): Yes, as part of a continuing process of general and preliminary studies of various areas in Canada to assess potential for parks development. (a) The studies involved map reviews and a short aerial reconnaissance. (b) They were made by the National and Historic Parks Branch. (c) No. They were made independently to ascertain if any areas might warrant joint consideration with the Province of Quebec.

- Hon. H. A. Olson (Minister of Agriculture): In so far as the Canadian Dairy Commission is concerned, the answer is: 1. The Canadian Dairy Commission does not have knowledge of all sales of dairy herds producing industrial milk. It has knowledge only of such sales with respect to which an application for the reallocation of the subsidy quotas is received.
- 2. From April 1 to December 11, 1970, subsidy quotas were reallocated to 3,050 parties following the purchase by them of all or part of the dairy herd of a quota holder.
 - 3. Nil.
- 4, 5 and 6. To extract and compile from the individual applications the details requested would require some 700 man hours. The Commission does not have the necessary staff for this purpose.
- 7. The total amount of quota reallocated was 8,758,290 pounds of butterfat.
