## AIRPORTS

POSSIBLE CLOSING OF MURRAY BAY AIRPORT

Hon. Martial Asselin (Charlevoix): Mr. Speaker, I should like to direct a question to the Minister of Transport.

I learned during the weekend that in view of a new policy of the Department of Transport which is no longer willing to make up deficits of local airports, the Murray Bay airport would be closed next summer thus causing considerable loss to the tourist industry in the Charlevoix constituency.

Hon. Donald C. ## AIR TRANSPORT

NEGOTIATIONS BETWEEN AIR CANADA AND EASTERN PROVINCIAL AIRWAYS RESPECTING ROUTES

Mr. Robert C. Coates (Cumberland-Colchester North): My question is directed to the Minister of Transport. Is the minister in a position to inform the House concerning any negotiations between Air Canada and Eastern Provincial Airways regarding air routes between Montreal and the Atlantic provinces and within the Atlantic provinces in consequence of which present Air Canada routes would be transferred to EPA?

Hon. Donald C. Jamieson (Minister of Transport): No, not in a specific sense, although, of course, as I have reported to the House on previous occasions, Air Canada is carrying on discussions with a number of regional carriers throughout the country with a view to the rationalization of the route structure. I do not know of any specific plans or talks at the present time, but I shall be glad to make inquiries.

Mr. Coates: Has the minister examined the recent Air Canada schedule relating to these routes, a schedule which sets back many years the type of service which has been available within the Atlantic provinces, and will he endeavour to secure the reinstatement of the type of service which was available up to April 24?

Mr. Speaker: The hon. member's supplementary is in the form of a representation and he has to assume it has been noted.
