Hon. Jean-Luc Pepin (Minister of Industry, Trade and Commerce): The Export Development Corporation (and its predecessor, the Export Credits Insurance Corporation) has no record of having insured credit in connection with the sale of goods destined for the Cabora Bassa Dam, nor has it issued guarantees, nor made loans in such a connection.

## RETURN OF THE JOHN HAMILTON GRAY TO BORDEN-TORMENTINE SERVICE

Mr. Gérard Duquet (Parliamentary Secretary to Minister of Transport): 1. Present plans call for the return of the M.V. John Hamilton Gray to the Borden-Tormentine crossing between October 15 and November 1. The exact date cannot be determined because of delays which may occur during her annual refit.

2. The normal refit for this vessel has been in the order of four weeks in the past. The additional work necessitated by the transfer of this vessel to the Newfoundland Service is estimated to take three days which may be able to be done concurrently with the annual refit to some extent. Until such time as the refit is well underway the exact number of days required cannot be determined.

Have there been any replies or counter-proposals put forward by the provincial governments in response to the federal government's plan regarding off-shore mineral rights, especially in regard to the division of the potential revenues from these offshore mineral and oil rights and, if so, what were these replies or counter-proposals and from which provincial governments were they received?

Mr. J. A. Jerome (Parliamentary Secretary to President of the Privy Council): Mr. Speaker, since the Prime Minister's announcements in December 1968 and March 1969, there have been many meetings and a great deal of correspondence between the federal government and provincial governments on the question of the management of off-shore mineral resources and the division of potential revenues from off-shore mineral and oil developments. Other suggestions have been made by certain provinces with a view to achieving the same objective as that announced by the Prime Minister.

When discussions with the provinces reach an appropriate stage, a statement by the government will be made.
