### HEALTH CARE

REQUEST FOR PROLONGATION OF SERVICES TO WASWANIPI, MISTASSINI AND GREAT WHALE RIVER CREE INDIAN BANDS— MOTION UNDER S.O. 43

Mr. Ian Watson (Châteauguay): Madam Speaker, I rise under the provisions of Standing Order 43, seeking the unanimous consent of the House to move a motion related to an urgent matter.

As a result of a conflict between the Cree Indians and the Quebec government over the health services budget, a new 32-bed hospital at Chisasibi (Fort George) is empty while tuberculosis and other serious diseases threaten three Cree communities which have so far been unable to reach agreement with the Quebec government on the terms and conditions of the transfer of health services of the two higher levels of government. Therefore I move, seconded by the hon. member for Laprairie (Mr. Deniger):

That the House strongly urge the Minister of National Health and Welfare to extend health services to the Cree bands of Waswanipi, Mistassini and Great

#### TRANSPORT

MAINTENANCE OF CROWSNEST PASS FREIGHT RATES—MOTION UNDER S.O. 43

**Mr. Rod Murphy (Churchill):** Madam Speaker, despite the fact that western farmers have expressed their support for the Crow rate as an essential component of an over-all transportation policy, the Liberal leader in Manitoba has called the Crow rate "a major handicap" to western agriculture. Therefore, I move, seconded by the hon. member for Selkirk-Interlake (Mr. Sargeant):

That this House abhors the statement by the Liberal leader which shows more sympathy for the views of the railways than those of western farmers and this House recognizes that such statements demonstrate why the Liberal Party is nearly extinct in the west; and further, that when Mr. Lauchlan, in the long tradition of defeated Liberal leaders, receives his Ottawa reward after the next Manitoba provincial election he not be appointed to any board or Crown corporation that deals with transportation policy.
