That the Minister of Agriculture be consistent with his philosophy of 1976 and ask his government to transfer the control of chicken import quotas from ITC to the Canadian Chicken Marketing Agency.

CBC PRODUCER ASSISTING KGB AGENT-MOTION UNDER S.O. 43

I move, seconded by the hon. member for York North (Mr. Gamble):

Whereas CBC producer Mark Starowicz assisted KGB agent Konstantine Geyvandov in compiling information on certain persons, allegedly on six different occasions, and also promised "to act on behalf of Soviet interests", that the CBC be required to give a public explanation as to why Mark Starowicz continues as producer of the public opinion influencing program "Sunday Morning" and, finally, as to why he is being considered at this very moment to head all CBC national news and public affairs programming.
