This Bureau is established to co-operate with employers, Trade Unions and others to bring about better relations between employers and employees, and is charged with the enforcement of the following Acts:

"The Manitoba Factories Act."
"The Shops Regulation Act."
"The Bake Shops Act."
"The Public Buildings Act."
"The Building Trades Protection Act."
"The Passenger and Freight Elevator Act."
"The Steam Boiler Act."
"The Fair Wage Act."
"The Electricians' License Act."
"The Licensing of Moving Picture Machine Operators and the Public Amusements Act."
"The Minimum Wage Act."

LAWS GOVERNING CHILD LABOR IN FACTORIES

No male child under fourteen and no female person under fifteen to be employed in any factory.

LAWS GOVERNING STEAM BOILERS AND STEAM ENGINEERS

All steam boilers except "Railway Locomotives", "Steam-boat Boilers", and "Boilers in Private Residences" must be inspected before being operated, and yearly thereafter.

All boilers carrying a pressure of over 20 pounds must be in charge of a licensed engineer.

LAWS GOVERNING ELEVATORS

Section 6.—No elevator shall be operated without a certificate being first obtained from the Bureau of Labor.

Section 12.—All persons operating elevators carrying passengers shall be over the age of seventeen years.

Section 13.—Every operator, before being allowed by the owner to operate any elevator used for carrying passengers, shall hold a license in accordance with schedule "C" to this Act granted by the Bureau of Labor, and such license shall be posted in a conspicuous place in the elevator car operated.

LAWS GOVERNING ELECTRICAL CONTRACTORS AND JOURNEYMEN ENGINEERS

All contractors must obtain a license from the Bureau of Labor, Section 10 of "The Electricians' License Act". All journeymen electricians must obtain a license from the Bureau of Labor, Section 12 of "The Electricians' License Act".

LAWS GOVERNING THE LICENSING OF MOVING PICTURE MACHINE OPERATORS

All Moving Picture Machine Operators must obtain a license from the Bureau of Labor as provided for by Section 18 of the "Public Amusements Act".

The co-operation of all labor organizations and others is desired to make the Bureau a success, and any information as to the violation of any of the provisions of the above-mentioned Acts will receive prompt attention, and be treated as strictly confidential.
