The Trend of Fashion.

In its November issue "Dress" discusses the new suggestions for women's wear.

Fascinating in the extreme are the advocate designs in every sort of gown, the eccentric of six weeks ago having already been so modified as to be now pictures in the best sense of the word, while the different shades of color are so graded that it would seem impossible not to be becomingly dressed.

Soft clinging fabrics with rare beauty of finish are to be noticed. Satin and soft finished materials are to be had in countless shades of color, while rare embroideries and lace continue to play an all-important part in the simplest as well as the most elaborate costumes. Hand-painted filmy fabrics for theatre and evening gowns are exquisite in color and design, and display a marvelous beauty of finish and perfection. The combination of lace and embroidery also affords opportunity for the most exquisite handwork, and there seems to be ample occasion, on even a rather simple cloth gown, for the display of some such ornamentation.

Altho trimmings of all kinds and descriptions are integral parts of the winter's fashions, a close study of the models produced by the leading houses shows that long, graceful lines are almost obligatory and that the trimmings preferably conform to this edict.

There is no positive rule as to the length of the winter coats. Charming, becoming, and attractive short coats, most elaborate in detail, are extremely fashionable. The always picturesque Louis XVI. fitted coat is exhibited in many variations, while the long empire coat and the half-length loose coats are exhibited in many variations of color, material and design.

At least one long coat will have to be included in the winter wardrobe for the light gowns of voluminous chiffon and such materials are to be worn all winter at luncheons, receptions and the theatre, and are necessarily hidden under wraps.

Cloth, velvet and fur will all be used for this purpose, and often these materials will be combined.

Hats, like gowns, have been modified by time, and there is less eccentricity to be noticed than a month ago in all millinery.

Coats of every kind and description are to be tremendously popular.

Long coats and entire gowns of fur are surprisingly popular considering the great cost.

Every possible variety of fur coat is fashionable, and the craze for beading and trimmings extends even here, for often a moire, Persian, caracul or seal coat is seen beaded and embroidered. To conservative minds lace and fur should never be combined, but in their natural beauty of texture, this however, is not an age of conservatism, and consequently fashion rides roughshod over many an old tradition.

The correct length for skirts and sleeves is still undecided, and both long-trimmed skirts and short ones are exhibited in the new models. Shirt sleeves are to be seen also in the short fancy style, and the short gowns, but a persistent and determined effort is being made by the conservative element to bring the long sleeve to the outer garment into favor again.

CASTELLANE LOVE LETTERS READ IN DIVORCE COURT

Profligate Count Wrote Avowing Sincere Repentance and Supplicating for Pardon.

Paris, Nov. 7.—When the hearing of the divorce suit brought by the Countess de Castellane (formerly Anna Gould) against her husband, Count Boni, was resumed to-day in the Palace of Justice before Justice Ditta, Maître Cruppi, counsel for the countess, briefly reviewed the points he had covered last week, referring to the reckless fashion in which the count had spent millions of the countess' money, while allowing her only a few hundred francs monthly for pin money.

An evidence of the countess' generosity, counsel cited the agreement of 1898, by which the count's father and mother were guaranteed a life income of \$600 and \$1000 respectively, and again laid special stress on the countess' intention not to abandon the country of her adoption, but to rear her boys as Frenchmen.

Maître Cruppi then plunged directly into the count's manoeuvres since the divorce proceedings were instituted to re-conquer his wife's affections.

Asked for Pardon.

After the failure of the attempt at arranging a reconciliation Feb. 1, when the countess was granted the temporary custody of her children, Count Boni commenced a systematic campaign, writing to the countess letters filled with avowals of sincere repentance, supplications for pardon, passionate words and professions of undying love.

On Feb. 25 the countess sent a cold rejoinder informing the count that she had suffered too much and had lost all affection for him and all confidence in his honor and veracity.

The count's tone then changed. On the next day he sent the countess a letter, in which he upbraided her for being a "mad woman, actuated by hate and vengeance," and saying that their children would some day reproach her for her "spitefulness." But the count soon resumed writing love letters to her, begging to be allowed to see her, and predicting that he would soon die.

Count Refused.

Finally the countess, worn out with the count's insanity, wrote him three postal cards, one of which read: "My response is the refusal of a respectable woman to see such a libel."

Continuing, Maître Cruppi declared that the count's paternal rights would be amply protected. The children would remain with the countess, but their father would have opportunities to see them and share in the direction of their education.

Condemned to Solitude.

Countess de Castellane's countess' sentence after to be a life sentence on the count for life, which he rejected because it did not include a full settlement of his outstanding debts. There was a flutter of excitement just before counsel closed his summing up, when he referred to a forgery in the possession of the other party, designed to "blacken the character" of a prominent attorney and a man conspicuous in public life.

Maître Cruppi concluded with the claim that the countess had been made out and a glowing appeal against calling witnesses, which he said would only bring disaster and ruin upon others.

Countess' Answer.

After recess Maître Bonnet, of counsel for Count Boni, read affectionate letters written by the countess to the count, exclusively of mischief-makers, and especially to the machinations of Edmund Kelly, the American lawyer, whose object was to obtain a big fee.

Maître Bonnet's attack on Mr. Kelly was particularly vicious, charging him with suborning witnesses.

Before he had concluded his reply the court adjourned until to-morrow.

BI-LINGUAL TEACHING

To Be Considered at Conference of School Inspectors.

The conference of Northern Ontario school inspectors with Hon. D. P. and officials of the education department at the parliament buildings yesterday will be continued to-day, when a series of resolutions will be formulated and the conclusions arrived at.

Among the questions under consideration are financial support, local and legislative; distribution of grants for poor schools, for current expenses, and for building and equipment of schools; bi-lingual and separate schools generally; supply and qualification of teachers; normal school at North Bay; development of continuing education; Truancy Act; appointment of an additional inspector and his qualifications; and redistribution of limits of inspection.

The conference was a private one, but the statement was made that the qualifications of bi-lingual teachers were under discussion. Along the west shore of the Ottawa River, Quebec teachers are in charge of the schools. While qualified under the Quebec regulations, it is felt that they should be compelled to conform to the Ontario requirements. A reasonable opportunity to do so would, of course, be afforded them.

There were 15 or 16 inspectors present. Rev. George Grant, Parry Sound, district, was in the chair. A. C. Paull, record clerk, education department, acted as secretary.

ORDER OF RECHABITES.

Washington, D.C., Nov. 7.—The resolutions favoring the restoration of the army canteen for the sale of beer and light wines to soldiers under proper restrictions, unanimously adopted. Addressed to the Independent Order of Rechabites of this city, perhaps the oldest temperance organization in the world, have aroused great interest in temperance circles.

Many members of this order are men who have served in the army, know all about the evil effects of excessive drinking from personal experience, and they realize that the abolition of the canteen is responsible for the increase of drunkenness among soldiers.

Under present conditions, the soldier drinks at low resorts on the outskirts of army posts, without any restrictions whatever. With the canteen, as advocated by the Rechabites, he will drink under government supervision and restrictions, under which over-indulgence is impossible.

In addition, the Rechabites propose that the government, in framing the canteen law, should discriminate strongly in favor of beer, which has a very small percentage of alcohol, and light wines. It is believed that the soldier will be satisfied with these beverages obtained under favorable conditions, and that he will be less likely to indulge in vile and ardent liquors than at present.

This action of the Rechabites has the support of army officers and military organizations. The Spanish war veterans, at their recent convention here, unanimously directed its legislative committee to press congress for the restoration of the canteen.

The Rechabites maintain that by making it possible for soldiers to obtain such comparatively harmless liquors as beer and light wines under government regulations, the cause of true temperance will be better upheld by driving them to low resorts beyond the government restrictions.

Women's Baptist Missions.

St. Thomas, Nov. 7.—The Women's Baptist Home and Foreign Missionary convention opened to-day. About 300 are in attendance.

Mrs. John Firstbrook of Toronto, the president, occupied the chair. Mrs. Gertrude Dayoff acted as convention secretary. The annual reports were read by Mrs. G. H. Campbell, recording secretary; Miss Webster, treasurer; Mrs. W. H. Porter, for the society paper, The Link, and Mrs. H. Lloyd, corresponding secretary, and Mrs. R. W. Daney for the bureau of literature. All the reports were of an encouraging nature. The most important report showed total receipts of \$713.53, and expenditures \$684.85, leaving a balance on hand of \$28.68. Last year's balance on hand was \$187.94.

At the afternoon session the officers were elected as follows: President, Mrs. Firstbrook (re-elected); first vice-president, Mrs. S. S. Bates, St. Catharines;

The treasurer of the foreign department reported total receipts of \$11,708.83, expenditures, \$12,075.51; deficit, \$366.63.
