REQUEST FOR LEGISLATION PROVIDING FOR FREEDOM OF ACCESS TO INFORMATION—MOTION UNDER S.O. 43

One year having gone by since the government clearly stated that it was drafting freedom of information legislation to which it was giving priority, and dozens of organizations, such as CUPE, the Canadian Bar Association, the Civil Liberties Association, Canadian teachers, Canadian consumers, and many others in their hundreds of thousands, having indicated their support for immediate action, I move:

That this House urges the government to ignore the self-serving views of the small group of highly placed government people who fear open government, and requests that the government bring in a bill, or instruct a parliamentary committee to do so, and also provide for a free vote in connection with the bill.

part of government policy and, if they do not, that this House request this government to clearly dissociate itself from such irresponsibility.

PROPOSED PAYMENT OF TRAVELLING COSTS OF CALPA AND CATCA EXECUTIVES—MOTION UNDER S.O. 43

Mr. Elmer M. MacKay (Central Nova): Mr. Speaker, I rise on a matter of urgent and pressing necessity pursuant to the provisions of Standing Order 43. In view of the attitude exhibited by the Department of Transport in invoicing CALPA and CATCA for transportation costs connected with bringing the executives of these organizations to Ottawa, at the request of Ministry of Transport officials, to resolve the crisis which crippled Canada's airline industry last June, in view of the circumstances whereby the ministry gave the impression that they could accept all financial responsibilities at that time for the transportation of these executives, who in fact played a constructive part in resolving the crisis, and in view of the lavish use of government aircraft by ministers of the Crown at the expense of the public for far less constructive purposes, I move, seconded by the hon. member for Dartmouth-Halifax East (Mr. Forrestall):

That the Ministry of Transport rescind or cancel these invoices and arrange payment from departmental funds for this very necessary and co-operative course of action by the executives of CALPA and CATCA in coming to Ottawa.
