

Record of the Declaration of a Court of Inquiry on the Illegal Absence of a Soldier.

RECORD of the Declaration of a Court of Inquiry assembled at *Algonquin Camp*
on the *23rd* day of *June*, 19*42*, for the purpose of investigating
and recording the absence, without leave, from his duty, and deficiency, if any, in the
Arms, Ammunition, Equipments, Instruments, Regimental Necessaries, or Clothing of
No. *A-21, Pte. Ciddle, Co., R.C.R., No. 1 C.D.I.R.V.*

DECLARATION.

The Court *finds*, that *A-21, Pte. Ciddle, Co., R.C.R. Coy. No. 1*
C.D.I.R.V. illegally absented himself without leave from *Algonquin*
Camp, at *2359 hrs.*, *31st May, 1942*, and that at *1530 hrs.*, *23rd*
June, 1942, he is still so absent and that he is deficient of
equipment and clothing to the value of seven pounds,
thirteen shillings and nine pence.
