CONSULTANT STUDIES ON SCIENCE POLICY

Motion No. 119—**Mr. Orlikow:**

That an Order of the House do issue for a copy of the five consultant studies referred to by the

Department of Industry, Trade and Commerce, in their submission to the Senate Special Committee on Science Policy, April 30, 1969, Appendix "K", Page 50, of that Department's submission.

Mr. Yves Forest (Parliamentary Secretary to President of the Privy Council): Mr. Speaker, of the five consultant studies referred to in the motion three can be tabled. The two remaining studies have not been completed. One of these is expected to contain industrial proprietary information which could not be made public. The second will be published exclusive of commercial confidential information within one year of the completion of data collection and analysis. It is expected that data collection and analysis will be concluded sometime in 1970. If the hon. member accepts these limitations and withdraws his motion, the Minister of Industry, Trade and Commerce (Mr. Pepin) is willing to table copies of the three studies.

Mr. David Orlikow (Winnipeg North): That is acceptable.

Mr. Speaker: Subject to the reservations and limitations expressed by the Parliamentary Secretary, is it the pleasure of the house that notice of motion No. 119 be deemed to have been adopted?
