of any such penalty or penalties, as if the same was or were a private debt due to the said Overseer of Overseers; and when recovered, shall be paid and applied, one half to the Overseers, and the remaining one half thereof to the County Treasurer, to be applied and expended under the directions of the Court of General Sessions of the Peace for the said County, on the Highways, Roads and Bridges, in the Township or Settlement where the said penalties may be incurred.

XIII. And be it enacted, That no Master or other person in charge or command of any Ballast not to Ship or Vessel, in any part of the anchoring ground in the County of Richmond aforesaid, be thrown oshall discharge or throw over any ballast from such Ship or Vessel, under a penalty of not less than Twenty Shillings, and not exceeding Five Pounds, to be sued for, recovered and

applied, as hereinbefore provided, with respect to other penalties.

XIV. And be it enacted, That this Act shall continue and be in force for one year, and To continue from thence to the end of the then next Session of the General Assembly.

CAP. XXV.

An Act for the suppression of Lotteries.

(Passed the 29th day of March, A. D. 1841.)

HEREAS, the disposing of Money or Goods by Lottery is productive of mischief: Preamble

I. Be it therefore enacted, by the Lieutenant-Governor, Council and Assembly, That any Persons selling ar nurperson who shall sell or offer for sale any Ticket for any Lottery, or any person who will purchase any such Ticket, shall forfeit and pay, for every such Ticket so sold or offered for ets liable to a sale, or purchased, a fine or penalty of Two Shillings and Sixpence; and any person who shall be the conductor or manager, or proprietor, or drawer, of any such Lottery, shall pay Conductor of Lottery liable to penalty of

II. And be it enacted, That all fines and penalties, imposed by this Act, shall be recoverable before any one Justice of the Peace for the County in which the offence shall be Penalties how committed, by any person who will sue for the same, in the same manner, by the same recoverable means and with the like costs, as if any such fine or penalty were a private and individual debt, due to the person so suing for the same; and, when recovered, shall be paid to the Overseers of the Poor of the Township or District where the offence was committed, for the use of the Poor of such Township or District.

III. And be it enacted, That this Act shall continue and be in force for two years, and To continue from thence to the end of then next Session of the General Assembly,

CAP. XXVI.

An Act to extend to the Village of Maitland, in the County of Hants, the provisions of the Act relating to Commissioners of Highways in Halifax and certain other places.

(Passed the 29th day of March, A. D. 1841.)

Ett enacted, by the Lieutenant Governor, Council and Assembly, That, from and after the passing of this Act, the Act passed in the seventh year of the Reign of His late Act 7 Wm. 4 Majesty King William the Fourth, entitled, An Act relating to Commissioners of Highways in Halifax and certain other places, and every matter, clause and thing, therein contained, Highways exshall be extended, and the same are hereby extended to the Village of Maitland, in the maitland Maitland

II. And be it enacted, That it shall and may be lawful for the Governor, Lieutenant Go-Three Comvernor, or Commander in Chief for the time being, by and with the advice of Her Majesty's missioner to be appointed.
