

Mayor Wilson says the opening of the new building will not be postponed, but will take place Nov. 15, as previously announced. Until the council formally turns the building over to the trust the patients can not be moved out of the old building, and the contractors will be delayed with their work in consequence. Th administration building will be furnished by the opening day.

Crankshaw's Criminal Code Sy nopsis.

We have received from the publisher* an analytical synopsis of the Criminal Code of Canada and of the Canada Evidence Act, 1893, by James Crank-shaw, B.C.L., of the Montreal bar, author of Crankshaw's Annotated Criminal Code, and of the Practical Guide for Police Magistrates and Justices of the Peace. The present volume is, as it professes to be, a concise synopsis of the statutory criminal and evidence law of Canada. It furnishes, without a word of unnecessary verbiage, in a small compass, a survey of the whole field, and will be very valuable to law students, justices of the peace and police officers, as well as to members of the legal profession, especially to those of them who are only occasionally called upon for the application of the criminal law, to whom it will act as a refresher. There is no index, which is perhaps as unnecessary in such a work as it would be in a directory; although we con-fess that in this age one wants to waste no time or trouble in arriving at what is wanted. The work is in-tended to be supplementary to the statute law, and fills a want which is

not otherwise attempted.
