Washington, Nav. 12. - An investigation of sanitary conditions existing generally throughout the rural districts of the United States is necessary, according to a statement issued spectators who had been pressed back day, giving the results of recent in-

vestigations made by its experts of farm water supplies in Minnesota, where, out of 79 water supplies examined, 59 of them were found to have been polluted. Twenty-three of the farms examined showed a record of typhoid fever. "Eleven of the wells examined," it

is declared, "could not be made safe from pollution, even with extreme care, owing to their location. The rivers, surface reservoirs, and cisterns are polluted, and it is doubtful if satisfactory water for farm use can be obtained from such sources.' The report states, in conclusion, that
