The following amendments to the Supreme Constitution and Statutes, of interest to each Grand Domain, were adopted:—

AMENDMENTS ADOPTED. Supreme Constitution.

Article VII., Section 6.—A Supreme Representative, at the time of his election or appointment must be a rast Grand Chancellor in good standing in his Grand Lodge, and in a subordinate lodge within its domain, not the holder at any time during his term of any office

on an actual and bona fide resident of the domain
of such Grand Lodge; and should a Supreme
of Representative become not in good standing in
or cease to be a member of his Grand Lodge
and of a subordinate lodge within its domain,

SUPREME STATUTES.

26. The revenue of the Supreme Government shall be derived from a per capita tax, fees for warrants and the sale of supplies.—In effect December 31st, 1898.

27. Each Grand Lodge shall pay to the Supreme Lodge, semi-annually, on the first days of April and October, each year, such per capita tax as may be determined by resolution at each biennial convention of the Supreme Lodge, for
