George; recognition of services of various deputy ministers; granting and conferring of titles and honours a prerogative of the crown; Halsbury's Laws of England on titles of honour, 91; exercise of prerogative of mercy by the governor-general; order-in-council of Sir Wilfrid Laurier in 1902 and the Nickle resolution of 1919, 92; combination of three estates in Canadian parliament; the 1919 titles resolution a pious opinion passed by the Commons alone, 93; decision of Lord Chief Justice Denman in *Stockdale v.
