COMPLAINTS RESPECTING POSTAL SERVICE

How many written complaints have been received by the Postmaster General and his department regarding the service presently available to the public since June 25, 1968?

Hon. Eric W. Kierans (Postmaster General and Minister of Communications): 16.217.

Note: The Post Office handled, in total more than 7 billion pieces of mail in this 17 month period.

In addition to the figure stated, departmental managers at headquarters and the field received a limited number of complaints of the miscellaneous category. These are not recorded and determining the total number would involve search of thousands of files at headquarters and in hundreds of field components, entailing delay in replying and a very substantial amount of labour hours and cost.
