REPRESENTATIONS RESPECTING RELEASE BY RUSSIA OF VALENTYN MOROZ AND SVIATOSLAV KARAVANSKYI

Mr. Steven E. Paproski (Edmonton Centre): Mr. Speaker, my question is for the Prime Minister. In view of the fact that the Ukrainian population of Canada is still celebrating the 53rd anniversary of the proclamation of independence of the Ukrainian national republic, and in view of the fact that many Ukrainians were illegally sentenced to concentration camps in Soviet Russia for exposing terror, racism, intellectual and cultural persecution and injustice against Ukrainians and other minorities in the U.S.S.R., would the Prime Minister inquire when he meets with Kosygin, Brezhnev and Podgorny about the release of Valentyn Moroz and Sviatoslav Karavanskyi who have been sentenced for acts of conscience which are described and guaranteed by the United Nations declarations as basic human rights?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, if the hon. member would give me the names in writing I will consider making representations.

FORWARD BARLEY SALES-USE OF FUTURES MARKET
