FULL INDEXATION OF FAMILY ALLOWANCE AND REPEAL OF TAX INCREASES

Mr. Neil Young (Beaches): Mr. Speaker, it is my privilege and duty to present a petition from residents of my own constituency who state that the deindexation of the universal family allowance is an unfair attack on women and families, and further state that this attach will not be offset by changes to the child tax credit and that other tax increases in the May Budget will place an unfair burden on low and middle-income earners.

While I have the floor, I have a similar petition to present from residents of the Province of Nova Scotia who also state that the deindexation of the universal family allowance is an unfair attack on women and families. Ms. Margaret Mitchell (Vancouver East): Mr. Speaker, I also have a number of petitions to present protesting Bill C-70 and the partial deindexation of family allowance. The first two petitions are from my riding of Vancouver East where many, many people have protested that this measure will create considerable hardship for families. They call on the House of Commons to reinstate full indexation of the universal family allowance.

The next petition is from the interior of British Columbia including Kelowna, Peachland and Penticton, all areas represented by Conservative Members, unfortunately. These petitioners are calling for the House of Commons to reinstate full indexation of family allowances.

Moving along eastward to Nova Scotia, there have been a great many petitions from that province recently. This particular one I am presenting is signed by residents of Dartmouth, Sackville and Halifax who also say that the family allowance Bill is very unfair to families and will create considerable hardship and there should be full indexation of the universal family allowance.

I also have a petition to present from a group called Women Against the Federal Budget, and most of these women live in Burnaby, British Columbia. They are stating that children are everyone's responsibility and they strongly oppose the budget proposals to reduce the cost-of-living protection of family allowance and demand that this proposal be withdrawn as soon as possible.

They say that in the opinion of the petitioners, the deindexation of universal family allowance is a massive cut-back in the public commitment to child benefits, is an unfair attack on women and families with children and especially single-parent mothers, and they therefore humbly pray and call upon the House of Commons to reinstate full indexa-
