That Bill C-49 be amended in Clause 14 by striking out lines 9 to 20 at page 7 and substituting the following therefor:

"14. (1) Subject to subsection (2), an individual who contravenes any provision of this Act is guilty of an offence punishable on summary conviction and is liable, for each day or part thereof during which the offence continues, to a fine of not less than \$500 nor more than \$1,000.

(2) Where an individual contravenes any provision of this Act while acting in the capacity of an officer or representative of the employer or the bargaining agent, the individual is guilty of an offence punishable on summary conviction and is liable, for each day or part thereof during which the offence continues, to a fine of not less than \$10,000 nor more than \$50,000."
