## ANGLICAN SYNOD OF BRITISH COLUMBIA CHAP. 30. (INCORPORATION).

6. It shall be lawful for the Corporation of the Bishop of British Bishop of B. C. may Columbia, or any other corporation, or any person or persons, to convey trast proper ties to the Synod. transfer any property, real or personal, held in trust by him or them for the aforesaid eleemosynary, ecclesiastical, or educational uses of the Church of England, or the Church of England in British Columbia, to the said Corporation, to be held in trust for the same purposes.

7. The said Corporation may exercise all its power by and through How powers of the the executive committee as established by the constitution aforesaid, synod are to be exor such other boards or committees as the said Corporation may from time to time appoint by resolution for the management of all or any of the affairs or property of the said Corporation, but in accordance only with the trusts relating to any property to which any special trust is attached; the said Synod may also appoint a treasurer or Appointment of treasurers, and make such regulations for the management and admin- officers. istration of its property as it shall see fit. The Corporation shall also have the right of appointing any officer or other needful agent or agents for the management of its affairs, and shall have all other rights necessarily incident to a body corporate.

8. The terms "the Church of England," or "the Church of England Interpretation. in British Columbia," in all deeds, instruments and documents that have been heretofore, or that may hereafter be, executed, dealing with real or personal property within the Province of British Columbia, shall mean, unless a different construction is gathered from the deeds, instruments or documents, that portion of the Church of England within the Province of British Columbia.

9. Any conveyance of real estate, or any interest therein, vested in Execution by Synod the Corporation shall be deemed to be duly executed for that purpose of deeds granting if the same has affixed thereto the seal of the Corporation, verified by the signatures of the Bishop for the time being of the Diocese of British Columbia, or his commissary duly appointed, and the secretary of the aforesaid executive committee; and a discharge of a mortgage, if executed in the same way, shall be deemed to be properly and effectively executed.

10. In all Acts of the Legislature of this Province heretofore passed Construction of this relating in any way to the Church of England, or to any of the Act with other Acts ecclesiastical or educational institutions in any way connected here- Church of England. with, and in all deeds, documents, and other writings heretofore executed where reference is made to the Diocesan Synod of British Columbia, either in direct terms or by implication, or to any officers or committees thereof, the same shall hereafter be construed as if the Corporation hereby incorporated, and the committees and officers thereof, were the body and the committee and officers referred to in
