## CANADIAN CULTURE

FEDERAL ASSISTANCE TO CULTURAL ORGANIZATIONS—  
MOTION UNDER S.O. 43

**Mr. Donald W. Munro (Esquimalt-Saanich):** Mr. Speaker, I rise on a matter of urgent and pressing necessity under the provisions of Standing Order 43. Last year, directly as a result of the Secretary of State's freeze on federal assistance to the arts in Canada, the result of which was, to quote the chairman of the Professional Association of Canadian Theatre, Dr. Gregory Poggi, "in spite of ticket price increases, 67 per cent of our members have had to cut back the number of their productions, 55 per cent have had to lay off staff, 74 per cent have had to reduce the number of actors employed, and 55 per cent have incurred a greatly increased deficit", the Secretary of State was subsequently able to convince Treasury Board to allocate an additional \$13.6 million for the pet cultural projects of his department, none of which went to sustain the very cultural institutions of our country which have time and time again proven their worth in promoting cultural expression and dialogue across Canada—

REQUEST ACCOUNT OF PEIGAN CRAFT LIMITED BE PAID
