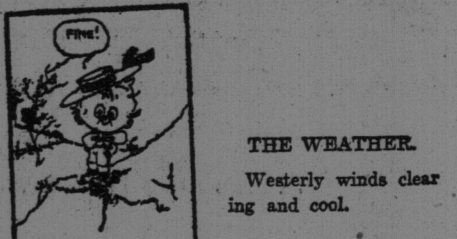

REMARKABLE PHENOMENON

Lake in Washington Which is Dark at Night for 24 Hours in Each Day. Spokane, Wash., Aug. 12.—Robert S. Fulton, a rancher living near Harrison, Wash., 22 miles southwest of Spokane, reports one of the most remarkable phenomena that he has ever witnessed. The people of Lincoln county in the discovery of Swan Lake, which is now as dark as night 24 hours of the day and one day after another. The lake is perfectly dry, but from 10 to 23 degrees cooler than the sunshine. Fulton recently travelled with a two-horse team along the shore of the lake and was in utter darkness for more than three-quarters of a mile. He thought it was a fog, and as the horses did not take fright, he did not become alarmed, but his little daughter was over-awed and cried loudly. The darkness covers the lake, which is a vast swamp and extends from 80 to 100 feet out from the shore. Many theories have been advanced by students of natural phenomena and experts, but the majority of people who visited the lake returned non-plussed and mystified. All the natural conditions appear to be normal except that it is dark, when there is light all around.

AUTOMOBILES BURNED IN A CHICAGO GARAGE

Chicago, Aug. 12.—More than fifty automobiles and taxicabs were destroyed today in a fire which consumed a one-story brick building at 1710-18 Indiana avenue, occupied by C. A. Coricose as a garage. The fire started with an explosion and burned so rapidly that the building was almost entirely destroyed before the arrival of the firemen. The total loss was estimated at \$300,000.

BRYAN WILL ACCEPT NOMINATION TODAY

Lincoln, Neb., Aug. 12.—With a salute of 45 guns, one for each state, given at daybreak, Lincoln began the celebration of its nomination day. The nomination ceremony will be held in the state capitol grounds at 2 o'clock. Representative Henry N. Clayton, of Alabama, chairman of the nomination committee, will deliver the address of his nomination as the Democratic presidential candidate in a short speech at the conclusion of which he will hand to the nominee the formal letter of nomination signed by all the members of the committee. Mr. Bryan will then reply and the ceremony will be closed by a short speech by John W. Kern, the vice-presidential nominee.

POLICEMAN SHOOTING INTOXICATED MAN

Augusta, Ga., Aug. 12.—At midnight last night Policeman Matthews shot and killed Edwin B. Turner, of North Augusta, S. G. Turner was up to a short time ago marshal of North Augusta.
