Dear Sir:

I am writing to you at the request of the Board of Directors of the Neighborhood Workers Association to place at your disposal information in regard to the work of the Association.

It is an increasingly common practice for those making their wills to include bequests to charitable organizations. Our Board felt that you might wish to have on file information in regard to the work of the Association. Under the laws of Ontario the Association is incorporated under the title of the Neighborhood Workers Association of Toronto, and it is thus empowered to receive bequests.

The Association carries on a family welfare work on a citywide scale working through a Central Office and nine District Offices which are strategically placed so that the needs of families in distress may be systematically and sympathetically met. 5300 families are assisted each year by the Association. This number will be greatly increased this year.

The Association also owns and operates Bolton Camp. A bequest intended especially for Bolton Camp could be left to the Neighborhood Workers Association with the restriction that it be used for this particular purpose. At Bolton Camp last summer 4549 children and mothers were given a twelve day holiday.

The letterhead gives the names of the Board of Directors of the Association. The character and ability of these men are a guarantee that any funds left at their disposal will be well administered, and that the wish of the donor will be scrupulously respected. Endowment funds are particularly needed. From time to time clients ask your advice in regard to organizations whose work is of a calibre to merit a bequest. We are ready at any time to give you the fullest information in regard to the work carried on by the Neighborhood Workers Association. The last copy of our Annual Report is enclosed.
