Both pleaded guilty to being brought into the province. Fitzgerald was sentenced to ten years in Dorchester, and Clisco to one year in the common jail at Yarmouth.

WOMEN RAISED LARGE AMOUNT

HALIFAX, N. S., Sept. 23.—Nearly twenty-five hundred dollars were raised by the Presbyterian women of the Maritime Provinces for missions during the past year. This was brought out at the thirty-second annual convention of the W. F. M. S. of that denomination in session at Saint John's Church, when the report of the Executive Committee was read. The total amount raised for foreign missions was \$2,521.19. It was secured for \$132 to pay for a motor boat for Rev. Mr. Dauby, a British Columbia missionary, also collected. Thus the total York county reached the sum of \$2,314.
