EMIGRATION AND PUBLIC IMPROVEMENTS .- It is generally admitted that, in order to provide for the numbers of poor people who will come to Canada during the summer, large publie works should be in progress, and to commence these, capital is necessary. The labourers will be here, but the wherewithal to hire them is wanting. We have several railway companies; ome preparing to commence operations, and the difficulty would be met were these companies enabled to prosecute their several undertakings vigorously and on a large scale. It has been suggested that for this purpose tracts of land, now at the disposal of the Government, might be made available, and such arrangements made as may, when the labourers shall have finished their work at the roads, place them in a position to benoisned their work at the roads, place them in a position to become settlers and landlords.
