(U.S.\$ millions)

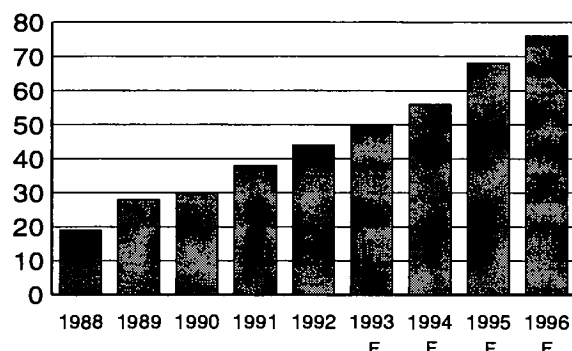
