outlined. Hopefully, this being the first such statement, we shall learn from our procedure. If there are to be modifications and suggestions regarding the format we shall use this morning, certainly, those can be considered in due course and the procedure can be adapted as we go along.

Is this agreed? Agreed.

Is the Minister of Supply and Services aware of a letter sent to the Chief of Media Relations, Mr. I. Rolstone on January 15, 1975 and (a) if so, on what date will the information requested be provided (b) if not, will the Minister request that the information be provided on (i) commodity procurement within the Engineering and Science Procurement Services (ii) records of efficiency and complaint of a specific nature respecting the Auditor General or the operational Audit Branch for over-expenditures on contracts (iii) instances when the Minister has over-ruled contracts recommended by his subordinates (iv) names of companies and appropriated amounts of money allocated to firms having had more than five contracts issued within the past year (v) a review of services and the cost of maintenance of the War Supply Agency? —Sessional Paper No. 301-2/1,937.
