## THE EVANGELICAL MENNONITE CONFERENCE

The house in committee on Bill S-11, to incorporate the Evangelical Mennonite Conference—Mr. McCleave—Mr. Rea in the chair.

On clause 1—*Incorporation.*

**Mr. McCleave:** Mr. Chairman, I intend to speak very briefly on this bill, which comes appropriately before us as we move into the holiest season of the year, that is Easter. It is perhaps appropriate that at this time we consider this measure in committee and, subsequently, give it third reading. I am not familiar with the precise nature of the religious community that is being established by this bill. I believe the hon. member for Lisgar will have a few words to say on that point in a few moments.

Since I stand for the sponsor of the bill, I should like to assure the committee that the bill has been given proper consideration in the other place and by the miscellaneous private bills committee, where the sponsor was pleased to attend and explain the provisions. I think I should say further that the 19 or 20 clauses in this particular bill are in the standard form for setting up these religious associations.

**Mr. Muir (Lisgar):** I should like to add to what the hon. gentleman has said concerning this bill that the purpose is to set up a central administrative body to administer the funds of the various congregations of this church, over and above that needed on the local level. It will co-ordinate the efforts of these congregations and enable the larger ones

to assist the smaller ones in getting established. It will also facilitate the distribution of church funds collected for missionary work in foreign fields. I think this is the same procedure that is used by the majority of churches of all faiths in this country. This measure will greatly assist this religious body in furthering its work amongst the people of that faith.

Clause agreed to.
