#### **UNITED NATIONS**

TRIBUTE TO CONTRIBUTIONS MADE BY CANADIANS SERVING IN PEACEKEEPING FORCES—MOTION UNDER S.O. 43

Mr. Marcel Prud'homme (Saint-Denis): Madam Speaker, 25 years ago today, on November 4, 1956, the General Assembly of the United Nations in special session adopted a resolution to resolve the Suez Canal crisis by the creation of a United Nations peacekeeping force under the command of a great Canadian, General Burns. This resolution, sponsored by the then secretary of state for external affairs, the Right Hon. Lester B. Pearson, in the name of Canada, marked the beginning of United Nations peacekeeping forces and won for its author the Nobel Peace Prize.

Pursuant to Standing Order 43 I therefore move, seconded by the hon. member for St. John's West (Mr. Crosbie) and the hon. member for New Westminster-Coquitlam (Miss Jewett):

That this House recognizes the contribution made by those Canadians who have served and continue to serve in these United Nations peacekeeping forces, and particularly those who lost their lives, and that this House renews its commitment to the United Nations effort to promote world peace.

## FOREIGN INVESTMENT REVIEW AGENCY

MINISTER'S POSITION—MOTION UNDER S.O. 43

Mr. Tom Cossitt (Leeds-Grenville): Madam Speaker, the attitude of the Minister of Industry, Trade and Commerce (Mr. Gray) toward changing the Foreign Investment Review Agency is resulting in keeping vital foreign investment out of Canada which, in my constituency alone, accounts for approximately 80 per cent of present industrial jobs created by American and British capital. I move, seconded by the hon. member for Winnipeg-Assiniboine (Mr. McKenzie):

That the Minister of Industry, Trade and Commerce clarify immediately whether or not he intends to proceed with serious curtailment of foreign investment in Canada, particularly American, and in relation to border areas such as Leeds-Grenville that the minister confirm immediately a government policy of discontinuing the practice of halting legitimate American investment at the New York State-Ontario border which has made him known as the minister of industry for northern New York State.
