INTEREST RATE CHARGED ON CREDIT CARD TRANSACTIONS

Mr. Howard Crosby (Halifax West): Mr. Speaker, the Parliament of Canada was effective in pressing the chartered banks into reducing interest rates on credit card transactions. It is now time for the Government of Canada, particularly the Minister of Transport (Mr. Crosbie), to look at Crown corporations and their interest charges on credit transactions.

Air Canada, through its En Route credit card, has been charging 19 per cent and more for credit card transactions. First, it does not incur the expenses of financial institutions on credit card transactions, and second, it gets special consideration from the Government of Canada with respect to the use of the En Route card.

It is time for Parliament and the Government of Canada to make Crown corporations practise what the Government of Canada has been preaching. I call upon the Minister of Transport to investigate Air Canada, determine what interest rate it is charging, and put an end to onerous interest rates.

### THE CONSTITUTION

MEECH LAKE AGREEMENT—GOVERNMENT POSITION

Right Hon. John N. Turner (Leader of the Opposition): Mr. Speaker, I have a question for the Deputy Prime Minister, in the absence of the Prime Minister. I carefully read the answers given by the Deputy Prime Minister yesterday on the subject of the procedure to be followed by Parliament once an agreement is concluded between the Prime Minister of Canada and his provincial counterparts.

The Deputy Prime Minister admitted that in 1982, amendments to the Constitution had been proposed by Parliament, but he did not say whether the Government would allow any amendments to the agreement expected to result from today's meeting. I therefore want to ask him very specifically: Will the existing precedents on constitutional matters be followed? Will it be possible to amend the accord or will the Government use its overwhelming majority in the House to block constructive amendments that would reflect the concerns of many Canadians?
