AGRICULTURE

Mrs. Christine Stewart (Northumberland): Mr. Speaker, the residents and constituents of Northumberland county wish the Prime Minister and the government had been as attentive to their needs.

Emergency assistance for cash croppers of corn and soybeans in my riding of Northumberland need help. Presently federally supported insurance programs have not provided the help needed. However, in today's estimates we see that instead of filling the program gaps we have further cuts to these programs.

In Northumberland county the weather conditions during the summer and fall of 1992 devastated corn and soybean crops. Approximately 80 per cent of the grain corn and 20 per cent of the soybean crops were not harvested. The direct income lost to county farmers is estimated at \$7.8 million with spin-off economic losses of up to \$78 million.
