## AFRAID OF BEING STABBED

Montreal Man Arrested Charged With Intimidation in Connection With Cigarmakers' Strike.

Why Some Workers Went Away.

Peculiar Condition of Things Prevailed Among Cigarmakers and Those Taking Their Places.

Montreal, May 11.—(Special.)—Anglo-Chinese, a Spanish cigar maker, was arrested this morning by Detective Gallagher on a charge of intimidation in connection with the present cigarmakers' strike. It is claimed that Chan and others were instrumental in getting two Cuban cigarmakers to quit the strike, and that they threatened violence and that for some days Chan has been endeavoring to induce Thomas Valdes to quit the employ of Koenigberg & Co., St. Maurice-street, and leave the city.

Valdes says that he and five other men came here about a week ago and have been working with Messrs. Koenigberg and they got so afraid of being stabbed that they worked in constant fright all the time. He says that two of his companions who went away got some money from the Spaniards and told that he better look out if he did not want to get into trouble. He told his employers about the threats and the offers of money to quit and go away.

Indecent Assault Charged.

Upon Complaint of Three Girls a Bank Clerk Was Arrested on Saturday Night.

Police Ward of the Wilton-avenue station had a lively chase thru the Donuts on Saturday night after a young man, who is charged with indecent assault, and he was arrested.

The girls were taken to the station, where the policeman came along just about the time the girls were walking away from the place and they complained to the officer, who at once took them to the station.

The prisoner was on his bicycle and either did not hear the policeman call to him or he did not want to stop, for he kept on riding towards the Gerrard-street bridge.

## OPEN TROLLEY RAN AWAY

With 115 Persons Packed Upon it the Motorman Lost Control When Going Down a Hill.

EVERYONE ON BOARD WAS HURT

When Rounding a Curve the Body of the Car Was Wrenched From the Tracks and Turned Over.

New York, May 12.—An open trolley car, on which were packed about 115 persons, got away from the motorman this afternoon near Fort Lee, N.J., and dashed down Lenox Hill. Every person on the car was bruised, but only one of them is likely to die—Frank Summuck, the conductor, who received possibly internal injuries. J. E. Robinson and his wife of this city were seriously hurt.

The heavily loaded car had started down an incline of a quarter of a mile in length, when the motorman lost control. It went so fast that no one dared to jump. The road is a winding one; at the foot of the hill the track curves sharply, and the rails at this point were laid specially to counteract such an accident as happened this afternoon.

When the front trucks hit the curve they started around and made it. The rest of the car followed part of the way. True wrenched upon the car, however, as it swung about, was so great that the body was wrenched from the tracks and rolled over and hit the ground. The motorman stuck to the car, and the jerk which pulled the car apart took place he shot into the air and landed in the soft earth near a fence at the corner. The passengers were caught in and under the car and were piled in a screaming, prostrate heap.

Another car was close behind, and under control, and on reaching the curve stopped and the passengers alighted. This gave plenty of hands to aid the ones pinned under the car and caught in it. Hundreds of three minutes later were out of the car. The injured were taken back to Fort Lee, where such as needed it received medical attention.

What caused the car to run away will probably never be known, as it is too badly wrecked to warrant an inspection which would prove valuable to settle the point.
