We should like to be able to discuss this matter and ascertain the views of the government. The Prime Minister will be going to New York today, I am informed, and will meet with the secretary general tomorrow. Following that, I think this house and Canadians generally have a right to more information than has yet been given either to this chamber or to the country at large.

Hon. Paul Martin (Secretary of State for External Affairs): I will say to the right hon. gentleman that I shall be glad to consult with my colleagues as to his request. I am hopeful that some day next week, depending on the action of the co-chairmen of the Geneva accord group, it will be possible to table the majority and minority reports of the international control supervisory commission upon which Canada serves. This will be of some assistance by way of making additional information available. It will not, of course, provide a solution to the problem which, quite correctly, the right hon. gentleman refers to as one in which we have an understandable interest and about which we have great concern. I will give consideration to his request.

Mr. Diefenbaker: Would the minister say when he expects to table those two reports?

Mr. Martin (Essex East): I am not quite certain. The report is in the hands of the two co-chairmen, the Soviet union and the United Kingdom. We have not as yet had any reaction from the Soviet union. If we do not get their permission we shall have to consider whether we will act on the decision of one co-chairman, or whether we will act on our own.
