

BONAR LAW RESIGNS FROM CABINET

Stewart and Dottle Appear And Demand They Be Sworn As Members for Restigouche

First Political Gun of the Session of the Legislature Fired This Morning—Opposition Leader Calls on Government to Produce Original Election Return

D. A. Stewart and H. J. Dottle, the Opposition candidates in Restigouche at the general elections last October, who were first returned as elected, then a recount demanded, and finally a protest filed, appeared at noon today before Sir Douglas Hazen, Chief Justice of New Brunswick, at the Assembly Chamber, and demanded that they be sworn in as members of the Legislature.

The appearance of Messrs. Stewart and Dottle was an extraordinary surprise, and when Hon. J. B. Baxter, leader of the Opposition, demanded that they be sworn in and seated as members of the first political gun of the session had been fired. Sir Douglas Hazen said he had been presented with a return by the Provincial Secretary showing the result of the election, and that he had elected Stewart and Dottle to the Legislature, and that he was bound to do so.

Hon. Mr. Baxter persisted that there had been a return made by the Sheriff of Restigouche county showing Messrs. Stewart and Dottle elected, and he again demanded that they be sworn in. Sir Douglas Hazen then ruled that if a return was presented to him showing Messrs. Stewart and Dottle elected he would have to allow them to be sworn in. Mr. Baxter called upon Hon. Dr. Hetherington to present the return which he said, had been sent by the Sheriff and which he said, he had seen himself in the Government offices. The Provincial Secretary said he was acting under instructions from the Attorney General. Premier Foster also took a hand in the discussion.

Messrs. Stewart and Dottle were not sworn in, and as soon as swearing in proceedings were completed the Opposition party went into caucus. When they adjourned Hon. Mr. Baxter said he was not in a position to make any statement as to what the next move would be regarding the Restigouche situation, but he intimated that something further would be done later on.

The Government Whips. Premier Foster announced this afternoon that the Government whips in the Legislature had been named by the caucus of the Government party.

The whips have on many occasions the past been appointed by the Premier, but Hon. Mr. Foster said it was not his intention to make the appointments this year. "The Government party's whips will be named."

POSTPONE WORK ON HUDSON BAY RY.

Minister of Railways Says It Must Be Deferred Until the Conditions Improve

Ottawa, March 17.—The Minister of Railways, Mr. Foster, announced yesterday that the work on the Hudson Bay Railway, which was postponed last week, would be deferred until the conditions improve.

P. F. Casgrain, Charlevoix-Montmorency, submitted a resolution that the ticket of leave extended to W. H. Tapley, of Montreal, should be cancelled and Tapley sent back to jail. Hon. Hugh Guthrie, acting Solicitor General, said that if Tapley committed an indictable offence his license should be revoked. Motion withdrawn.

Motion by J. A. Campbell, Nelson, Man., that the Hudson Bay Railway should be completed, Dr. Reid opposed the motion, asking that the matter be deferred till better financial conditions prevail. The motion was carried by a majority of 10.

Chicago, March 17.—Every night since he killed his wife and their unborn child last June, Carl Wanderer has talked with her spirit, according to testimony given yesterday by Dr. Harold D. Singer, state alienist, at Wanderer's trial on charges of murdering the "ragged" stranger alleged to have been paid to stage a fake holdup.

Dr. Singer said that Wanderer had told him that Mrs. Wanderer had come to him in the night, dressed in a gown and holding a child in her arms. The witness said he considered Wanderer sane. Two other alienists also testified yesterday that Wanderer's sanity, their appearance being the end of the state's case in rebuttal.

ENGLAND REFUSES DEPORTEES OF U.S.

Undesirables Deported From United States Not Allowed to Land in England

Plymouth, Eng., March 17.—A number of undesirable aliens deported from New York on the steamer Kronland were refused permission to land here yesterday, although they had originally embarked for the United States in this country on the Atlantic.

The action of the authorities came after discovery that eighty Russians deported from the United States had landed here last week.

Up to Steamship Company.
Washington, March 17.—Officials of the Bureau of Immigration said last night that they had no knowledge of the party of deported aliens that were refused permission to land at Plymouth, England, yesterday.

Undesirable Russians, they said, are sent to Lisbon and thence to Riga. If the party is made up of immigrants who have been refused permission to land, they added, the matter is entirely up to the steamship company that brought them over.

**WILL FACILITATE
VISITS TO FRANCE**

Government Regulations Suspended to Facilitate Travel by Foreigners

Paris, March 17.—Fresh regulations to facilitate visits of foreigners to France have been put into effect by the government. A distinction has been drawn between the citizens of Allied countries and former enemy nations in the regulations.

In the past, Allied visitors remaining in France for two weeks have been compelled to take out identification cards at the Prefecture of Police. Under the new plan such card will be required if the visitor intends to stay two months.

U. S. Railroads are Appealing To the Railway Labor Board to Make Reductions Effective

The New York Central Would Start the New Wage Schedule on April 1st and Other Roads Will Follow the Central if the Appeal Allowed

New York, March 17.—The New York Central Railroad, whose wage revision proposals have been rejected by unskilled labor, today forwarded a petition to the Railway Labor Board in Chicago asking that tribunal to make the proposed reductions effective tentatively on April 1st.

The board's final decision in the wage controversy would be made retroactive to that date, the petition provides.

Officials of the New York, New Haven and Hartford, whose wage plans affecting unskilled labor also have been rejected by the employees, announced they would carry their case to the Labor Board in an ex parte appeal.

Union and railroad officials here agreed that the cases of the New York Central and the New Haven would constitute a test of questions raised in railroad wage controversies throughout the United States.

Packing House Strike Vote.
Chicago, March 17.—Reports of the strike vote taken at middle west branches of the five big packers' unions today and it was understood they indicated a large majority are in favor of a strike. Full power to call the walkout was placed yesterday in the hands of Dennis Lane, secretary treasurer of the Amalgamated Order of Meat Cutters and Butchers' Workmen, and R. C. Brennan, counsel for the union, at a meeting of the heads of the other unions involved in trades employed in the stock yards.

Reduced Wages Voluntarily.
Mobile, Ala., March 17.—Organized bricklayers and plasterers of this city last night voluntarily reduced their wages from ten dollars to eight dollars per day, giving as the reason the reduction in cost of living.

TO FREE FARMERS FROM INCOME TAX

President of Ontario Manufacturers Association Makes the Suggestion
